Pro Se Defendants:

The most efficient way to receive discovery is through a JusticeWeb account. This service is free and simple to sign up for and use. Please take a copy of **PRO SE FORM #1*** which provides instruction on signing up. You do not need to fill out **PRO SE FORM #2*** if you are signing up for JusticeWeb.

If you do not have access to the Internet and will need discovery in hardcopy there are fees. Please fill out **PRO SE FORM #2** and leave it at the security desk. You will be contacted when discovery is available. Please take a copy of **PRO SE FORM #1** for your information.

If at any point you wish to speak to the assigned prosecutor regarding your case you will first need to review and sign **PRO SE FORM #3***. The signed form must be in your file for the prosecutor to speak with you.
